Fees: \$60.00 total for 2 days for each 10' x 10' Craft/Information Booth

For those contracts received by the Festival by June 1, 2010, a discounted fee of \$45 will be accepted.

All vendors will be entered into a drawing for a free space for the 2011 Festival. The drawing will be September 19, 2010

Make check payable to Tiffin-Seneca Heritage Festival and mail it, with your completed and signed contract, to the address below. NO REFUNDS, unless space is not available or contract is rejected. Your canceled check is your receipt. PLEASE INCLUDE A STAMPED, SELF-ADDRESSED legal size envelope for confirmation. All signed contracts must include full payment of fees to reserve your location and be accepted. CONTRACTS SHOULD BE RETURNED BY 8/02/10. Set-ups start on Friday at 3:00pm till 8:00pm or Saturday by 9:30am and Sunday; by 10:30am. VEHICLES MUST BE REMOVED FROM THE AREA BY THESE TIMES. No set-up is permitted after these times. No teardown is permitted before 5:00pm on Sunday. All boxes and container must be kept out of sight. Tables must be covered to the ground in the front and on all sides. All food service and fire safety regulations must be followed. Exhibitor must provide their own tables, chairs, display racks, etc. Each exhibitor's area must be kept clean during and after the show. **Trash is to be put in dumpsters provided.** The Tiffin-Seneca Heritage Festival will not be responsible for any theft, loss, liability, property damage or accident but the Festival will provide off duty police officers to patrol the area after festival hours. **ELECTRICAL OUTLETS ARE AVAILABLE ON A LIMITED BASIS. No auxiliary power sources will be allowed!**

THE CONCESSIONAIRE AGREES:

1. As partial consideration for being allowed to participate in the Tiffin-Seneca Heritage Festival in Tiffin, Ohio that they are an Independent contractor and not an agent for the committee.
2. That they are solely responsible for the good nature and satisfactory quality of the product or service provided.
3. That they will not hold the Committee or its Members liable for theft and/or vandalism.
4. That, if for any reason, they should be sued for their own actions or inactions, they will not attempt to require the committee or individual members of the Tiffin-Seneca Heritage Festival to share any responsibility, blame, or liability or loss.
5. The concessionaire hereby indemnifies and holds the Tiffin-Seneca Heritage Festival and City of Tiffin harmless for any liabilities, losses, damages, claims or lawsuits brought against the Concessionaire or against the above-mentioned parties.
6. No items may be offered for sale that may be considered harmful, dangerous, or offensive. Items like silly string, poppers, caps, exploding devices, fart spray, or any item which strongly promotes violence, nudity, could create litter problems or in any way be offensive to the general public, are strictly forbidden. It will be the chairperson's discretion as to any such item in question. Anyone found selling the above will be asked to remove them or will be banned from the festival immediately without refund.
7. Your booth location is stationary. You may not roam the ground to sell your product.
8. No pets are allowed in the festival area.
9. No bicycles, roller blades, skateboards, scooters, etc are allowed in the festival area.
