**WHEN: SET-UP NOON, FRI. SEPTEMBER 17; FESTIVAL: SAT. & SUN., September 18 & 19, 2010**  
**TIME: FRIDAY 6:00PM TO 11:00PM: SATURDAY 10:00AM TO 11:00PM: SUNDAY 11:00AM TO 5:00PM**  
**FEES: \$18.00 PER FOOT OF FRONTAGE (INCLUDES TONGUES, AWNINGS, WORK AREA, ETC) PLUS UTILITIES CHARGES**  
**The depth for each unit is 10 foot out from curb, which includes awning, the units must be parked vertically only. NO REFUNDS, unless space is not available or contract is rejected. Your canceled check is your receipt. All signed contracts must include full payment of fees to reserve your location and be accepted. Contracts should be returned by 8/01/09. direct all inquires to: Larry Luzader, Food Chairperson, 567-230-4569. ALL Set-ups must be completed by 6:00pm Friday and VEHICLES MUST BE REMOVED FROM THE AREA by these times. No set-up is permitted after this time. No tear down is permitted before 6:00pm each day. Each concessionaire using utilities should have the required water line and electric cable and must provide their own adapters and items needed for hookup. all boxes and containers must be kept out of sight. Exhibitors must provide their own tables, chairs, display racks, etc. Picnic tables will be available at limited locations and will be your responsibility to police liter around them, if in your area, or they will be moved. For safety, must have a approved back flow preventer, all outside grilling areas must be fenced off. Each concession must have a 5 lb. or larger UL approved class ABC fire extinguisher, if deep frying must have Class K Fire Extinguisher. Each concessionaire must obtain liability insurance and furnish the chairman a certificate when making payment. EACH EXHIBITOR=S AREA MUST BE KEPT CLEAN DURING AND AFTER THE SHOW. Trash is to be put in dumpsters provided. The Tiffin-Seneca Heritage Festival will not be responsible for any theft, loss, liability, property damage or accidents. Please remember that this is an outside show and most set-ups will be on concrete or asphalt. NO ITEMS MAY BE OFFERED FOR SALE THAT MAY BE CONSIDERED HARMFUL OR DANGEROUS. ITEMS LIKE SILLY STRING, POPPERS, EXPLODING DEVICES, OR ANY ITEM WHICH STRONGLY PROMOTES VIOLENCE, NUDITY OR COULD CREATE LITTER PROBLEMS IN THE STREET, OR IS IN ANY WAY OFFENSIVE TO THE GENERAL PUBLIC ARE STRICTLY FORBIDDEN. It will be at the Chairman=s discretion as to any such item in question. Anyone found selling the above will be asked to remove them or will be disconnected and banned from the festival immediately without refund. Please do not bring any pets. They will not be allowed in the festival area.**

**The concessionaire agrees:**

- 1.As partial consideration for being allowed to participate in the Tiffin-Seneca Heritage Festival in Tiffin, Ohio that they are an independent contractor and not an agent for the committee.
- 2.That they are solely responsible for the good nature and satisfactory quality of the product or service provided.
- 3.That they will not hold the Committee or it Members liable for theft and/or vandalism.
4. That, if for any reason, they should be sued for their own actions or inactions, they will not attempt to require the committee or individual members of the Tiffin-Seneca Heritage Festival to share any responsibility, blame, or liability or loss.
5. The concessionaire hereby indemnifies and holds the Tiffin-Seneca Heritage Festival members and City of Tiffin harmless for any liabilities, loses, damages, claims or lawsuits brought against the Concessionaire or against the Tiffin-Seneca Heritage Festival.
