## **Purpose of the Royalty Court**

The *Tiffin-Seneca Heritage Festival Royalty Court* has been a part of the *Tiffin-Seneca Heritage Festival* since the inception of the festival. The pageant was brought back, so we hope to continue this tradition for years to come!

The purpose of the *Tiffin-Seneca Heritage Festival Royalty Court* is to function as both a representative and as an ambassador to the *Tiffin-Seneca Heritage Festival*. Being a member of the *Royalty Court* is important because the *Royalty Court* members are the face of the festival whenever in the public spotlight. All *Royalty Court* members will be expected to represent the festival at county fairs, local and other festivals, and other events and activities in Seneca County and throughout the state of Ohio (when and where applicable).

### **Royalty Court Titles**

The *Tiffin-Seneca Heritage Festival Royalty Court* will consist of the titles listed below. Each title will be associated with a specific age group.

Individuals who hold the title of *Queen's First Attendant* will take over for the *Queen* if/when the *Queen* must step down from the position of *Queen* and is not able to fulfill the duties of the title. The Queen's First Attendant will follow the same schedule and participate as a member of the *Royalty Court*.

Individuals who hold the title of *King's First Attendant* will take over for the *King* if/when the *King* must step down from the position of *King* and is not able to fulfill the duties of the title. The *King's First Attendant* will follow the same schedule and participate as a member of the *Royalty Court*.

# Attitude and Teamwork

Having a positive attitude is one of the most important qualities of any *Tiffin-Seneca Heritage Festival Royalty Court* member. All *Royalty Court* members will be required to have a positive attitude toward each other, the *Royalty Court Committee*, other festival *Royalty Courts* and associated personnel, and the public at all times. In addition, all *Royalty Court* members are expected to act in a positive and appropriate manner that will not harm the *Tiffin-Seneca Heritage Festival*. Failure to maintain a positive attitude may result in disqualification from holding the *Royalty Court* title.

All *Tiffin-Seneca Heritage Festival Royalty Court* members must always function as a team. Unless a decision is made directly by the *Royalty Court Committee*, no other decision will be made by a single individual unless all the *Royalty Court* members have discussed the topic first. Ultimately, the *Queen* and *King* in addition to the *Royalty Court Committee* have a significant role in the delivery of information and decision-making process; however, all *Royalty Court* members will be given the opportunity to provide feedback with a specific timeline before a final decision is made about all events and activities. Once a decision is made, an email and/or text message will be sent out to all *Royalty Court* members.

# Appearance and Attire

It is especially important for all members of the *Tiffin-Seneca Heritage Festival Royalty Court* to always uphold the best appearance and attire when out in public.

The appearance of every member of the *Tiffin-Seneca Heritage Festival Royalty Court* must always be a priority. It is important to ensure that every *Royalty Court* member maintains a

standard of appearance that includes clean clothing and shoes, appropriately styled hair, hygienic skin and nails, and overall, a well-kept personal exterior.

Members of the *Tiffin-Seneca Heritage Festival Royalty Court* must adhere to the attire requirements provided below for all festivals, parades, luncheons, county fairs, and other events and activities. Sashes and crowns will be provided to all members of the *Royalty Court* to wear during ALL events and must be kept in excellent quality at all times. If the sash and/or crown are damaged in any way that is irreparable, it will be the responsibility of the parent/guardian to purchase the same replacement item as soon as possible. All other items that are a part of the attire requirements must be purchased by the parent/guardian of the *Royalty Court* member.

Any member of the *Tiffin-Seneca Heritage Festival Royalty Court* who does not adhere to the appearance and attire standards will be given three (3) chances to fix the issue and then asked to step down as a member of the *Royalty Court* when the issue is not resolved.

Fundraising events and activities will be discussed and decided upon as a team alongside the *Royalty Court Committee*. More information about the fundraising will be provided later.

### Attendance and Participation

It is especially important for the members of the *Tiffin-Seneca Heritage Festival Royalty Court* to participate in all required events and activities, especially when the event or activity is a team-based event or activity requiring all the *Royalty Court* members to make it successful.

It is understood by the *Royalty Court Committee* that things in life can happen that are out of all our control, so it is particularly important to communicate any conflicts that may arise as soon as possible. Failure to attend multiple scheduled events and activities without appropriate and communicated reasons may result in disqualification from holding the *Royalty Court* title.

#### **Transportation Requirements**

Transportation of *Tiffin-Seneca Heritage Festival Royalty Court* members to and from any festival, parade, luncheon, county fair, or other events and activities must be coordinated directly by the parent and/or guardian. No *Royalty Court Committee* member will transport any *Royalty Court* member at any time unless for immediate safety/security or medical emergency reasons. Parents and guardians will be responsible for all transportation needs as it pertains to driving the members of the *Royalty Court* to and from all events. Parents and guardians in addition to all members of the *Royalty Court* will not hold any member of the *Tiffin-Seneca Heritage Festival* or *Royalty Court Committee* responsible for any transportation requirements.

Transportation required during parades may be completed by a *Royalty Court Committee* member or *Royalty Court Committee* member interim appointed person for the purpose of pulling a vehicle trailer where members of the *Tiffin-Seneca Heritage Festival Royalty Court* will ride from the start of the parade, to the end of the parade, and potentially to a drop off point. The appointed interim person who drives the vehicle will be a licensed driver in the state of Ohio over the age of 18.

The *Tiffin-Seneca Heritage Festival* and *Royalty Court Committee* are not responsible for any accidents or injuries that may occur before, during, and after all events and activities where the *Tiffin-Seneca Heritage Festival Royalty Court* members may participate on behalf of the *Tiffin-Seneca Heritage Festival*.

The *Tiffin-Seneca Heritage Festival* and *Royalty Court Committee* are not responsible for lost or stolen personal items that may occur before, during, and after all events and activities where the *Tiffin-Seneca Heritage Festival Royalty Court* members may participate on behalf of the *Tiffin-Seneca Heritage Festival*.
